SUMMARY OF REVISIONS

Updates terminology.

★1. Composition. The Enlisted Executive Advisory Council (EEAC) shall be composed of seven primary participating members and five alternates. The Command Chief Master Sergeant, CA ANG, shall be the Chairperson, and the Headquarters, California Air National Guard Human Resource Advisor will serve as an EEAC member. The 129th Rescue Wing, 144th Fighter Wing, 146th Airlift Wing, 163rd Air Refueling Wing, and 162nd Combat Communications Group shall each have one primary member and one alternate member. The primary member will be the Wing Command Chief Master Sergeant/Group Senior Enlisted Advisor, and the alternate will be a unit senior noncommissioned officer designated by the Wing/Group commander.

1.1. In the absence of the State Command Chief Master Sergeant, the senior member present will assume the duties of the chairperson.

2. Objectives.

2.1. To encourage two-way communication between command and the enlisted force at all levels to foster understanding and to enhance mission accomplishments.

2.2. To support programs and to offer suggestions to improve the effectiveness of the noncommissioned officer in the leadership and management role.

2.3. To promote understanding and support of command policies and objectives.

2.4. To evaluate and to develop programs that will encourage loyalty, patriotism, and dedication in the enlisted ranks.

2.5. To provide a voice for the enlisted force to present potential problem areas and to recommend solutions to elicit constructive suggestions for improvement of the California Air National Guard.

3. Enlisted Executive Advisory Council Meetings. The council will meet semiannually at a place and time designated by the chairperson. The council will meet at other times at the call of the Commander, California Air National Guard, through the chairperson.

4. Newsletter. Minutes of each meeting will be taken and incorporated into the EEAC Newsletter as appropriate. Additional progress or onetime reports will be forwarded as appropriate. Copies of meeting agenda and minutes will be provided to each member of the Enlisted Executive Advisory Council to brief enlisted personnel and commanders at their respective bases.

4.1. The Enlisted Executive Advisory Council Newsletter will be made up from meeting notes to share meeting highlights and communicate with the enlisted force as needed. The Newsletter will be distributed semi-annually to all units of the California Air National Guard for posting on bulletin boards and for briefing enlisted members on Council matters. Distribution will include the State Headquarters for information and staff action as required.

5. Relationship with Bases. The Enlisted Executive Advisory Council cannot carry out its assigned mission without an effective liaison with field units. Unit First Sergeants, base enlisted advisory councils, and all other individuals are encouraged to establish and maintain contact with the Enlisted Executive Advisory Council to insure intercommunication on important issues. The following methods will be used to help attain these relationships:

5.1. The scheduled periodic visits to the field units by the Command Chief Master Sergeant, California Air National Guard, during Unit Training Assemblies.

5.2. The free and continuous interchange of information through briefings by Enlisted Executive Advisory Council members at their respective bases .

5.3. The appearance before or observation of Enlisted Executive Advisory Council Meetings by individuals desiring such exposure. Prior arrangements will be required to effect the necessary coordination. A letter to the Command Chief Master Sergeant, ANG/CCC will suffice.
