COMPLIANCE WITH THIS PUBLICATION IS MANDATORY

ANGI 36-2002, 1 Mar 04, is supplemented as follows:

2.1.7.2. (Added) Statement of Physical Condition. Whenever there is a difference between the date of physical and date of enlistment, the enlistee will sign a statement declaring there has been no change in his/her physical condition since the date of his/her physical examination. This letter is to be copied and sent to HQ CA ANG/DP-A-Z as an attachment to the enlistment package. Additionally, weight or body fat must be completed and annotated on this statement.

There has been no change in my physical status since the date shown on this Standard Form 88.

2.6.12. (Added) CAL NG Form 600-2, Statement of Understanding - Overseas Training. Upon enlistment a CAL NG Form 600-2 will be accomplished. The enlistee will be briefed on the possibility of performing active duty for training outside of the United States. One copy will be retained at base level and one copy will be forwarded to HQ CA ANG/DP-A-Z with the enlistment package.

2.6.13. (Added) A copy of the member's DD Form 214, NGB Form 22, DD Form 365, AF Form 526, and any other supporting documentation (i.e. retirement points, pay documents from other military components) will be forwarded with the enlistment package. This documentation will be used to verify eligibility of satisfactory service for retirement.

2.6.14. (Added) Prior service enlistment packages will include the documents specified in attachment 1 of this supplement. Non-prior service enlistment packages will include documents specified in attachment 2.

2.10. (Added) Enlistment records will be forwarded to ARPC/DSMP and HQ CA ANG/DP within 30 days of accession.

4.12. (Added) A CAL NG Form 600-2, Statement of Understanding - Overseas Training and a statement of physical condition will be completed for reenlistments.

4.13. (Added) Reenlistment and extension packages will include the documents specified in Attachment 3 of this supplement.
